# Privacy notice for general information on the collection, use and disclosure of personal information in a form of photographs and moving images

# Background

The Victorian United Nations Day of Vesak Inc. is bound by the National Privacy Principles and holds no exemptions under the Privacy Act 1988 (Cth) (Privacy Act).

The Victorian United Nations Day of Vesak Inc. collects personal information in a form of photographs and moving images, which is used on an ongoing basis, to promote and publicise the celebration of United Nations Day of Vesak in Victoria.

Photographs and moving images constituting personal information may be taken by or on behalf of the Victorian United Nations Day of Vesak Inc., in circumstances where consent has either been formally obtained or implicitly obtained from a person's attendance at an event which is being photographed or recorded. Where this occurs, the Victorian United Nations Day of Vesak Inc., Victorian Buddhist temples and local supporters may use the photographs or moving images for purposes associated with promoting the celebration of United Nations Day of Vesak.

# Information collect and disclose

Personal information in a form of photographs and moving images collected by the Victorian United Nations Day of Vesak Inc. may be made available to media, general public as well as local supporters.

- in whole or in part, and to permit other persons to do so.
